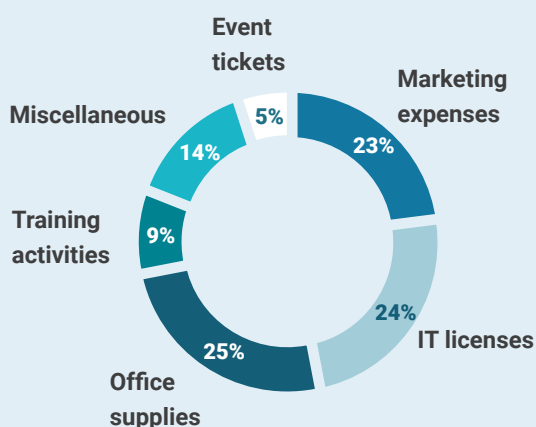
AirPlus Virtual Cards come in two varieties:

What are **single-use** AirPlus Virtual Cards most often used for?

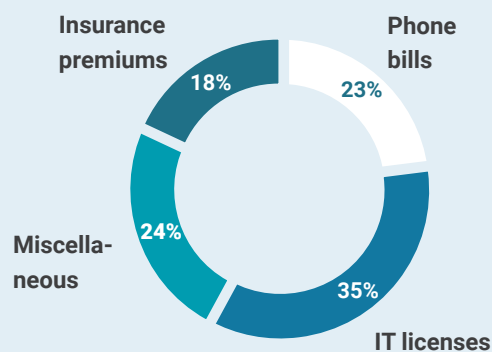


Multi-use:
